7. ENTRY FEES

7.1 The entry fee is 150 EUR incl. insurance and all other fees for every car for first closing date. Entry fee for second closing date is 250 EUR incl. insurance and all other fees. Entry fee will be collected on the administrative checking.

7.3 Entry fees may only be refunded in the case of the Event not taking place.

8. INSURANCE

8.1. Organizer is insured against claims caused to the third party in terms of the insurance closed between Vienna Insurance Group and Autoclub Česká republika number 00 1394 3081 in the high of 5,000.000,- CZK.

8.2. The entry fee includes the insurance premium, which guarantees the competitors cover for Civil Responsibility towards third parties. Participants are insured against claims caused to the third party in terms of the insurance closed between Vienna Insurance Group and Autoclub Česká republika number 00 1394 3081 in the high of 3,000.000,- CZK with the participation 10.000,- CZK. A property up 10.000,- CZK will be paid by drivers and over 10.000,- CZK by insurance.


8.3. Every driver must present their personal accident insurance policies and he must show proof during administrative checking by request. Personal insurance foreigners drivers must involve refundment of costs for treatment in the Czech republic.

- 11.1** Any car taking part in the Event must be presented by the driver or his official representative to scrutineering, which will be held at the paddock on 24.04.10 from 08h00 to 12h00.

There will be 4 laps in the qualifying Heats.

There will be 5 laps in the Finals.

- 16.6 Flag signals**
If a black flag is shown in a heat, the driver has to go immediately to the paddock or to the departure place in the middle of track; in a final, he has to go to the Parc Fermé or to the departure place in the middle of track

- 18. PARC FERME**
Parc Ferme, after finals, will be near racing track
- 20. PROTESTS – APPEALS**
- 20.1** All protests will be lodged in accordance with the Code. All protests must be made in writing and handed to the Clerk of the Course or his assistant, or in their absence any of the Stewards of the meeting, together with the sum of 10.000,- CZK. If the protest requires the dismantling and re assembly of different parts of a car, the claimant must make a deposit to a value not exceeding 250.000,- CZK.
- 20.5** Competitors have the right to appeal, as laid down in Articles 181,182 and 183 of the Code and also as set out in the Rules of the International Court of Appeal. The amount of the appeal fee is 20.000,- CZK.

- 22. FIRE EXTINGUISHERS**
Each driver is responsible for ensuring that a single piece fire extinguisher of min. 5kg is available within his own team's area inside the paddock.
- 23. ENVIRONMENTAL POLLUTION**
Each driver is requested to ensure that a plastic sheet (minimum dimensions 4 metres by 5) is spread on the ground in the place reserved for his team where work is to be done on his car, in order to prevent any pollution in case of an accidental leak, etc.
- 24. DRIVERS' LIAISON OFFICER**
The Drivers Liaison officer is marked with white tabard with logo of Autodrom Česká Lípa.
