8. INSURANCE

8.2. The entry fee includes the insurance premium, which guarantees the competitors cover for Civil Responsibility towards third parties. Participants are insured against claims caused to the third party in terms of the insurance closed between Gothaer Allgemeine Versicherung AG and Autoclub Česká republika number 92100.209200 in the high of CZK 5,000.000.
