6. General Regulations

The event is organized in accordance with the International Sporting Code (the Code) and its Appendices and the Regulations of the FIA Central Europe Zone Circuit Trophy, in accordance with National Sporting Codes (SAMŠ 2008 Year-Book) and the Regulations. In the event of differences between these various texts, the Code and its Appendices take precedence.

By participating in the race, the participators agree to conform to the Code /Article 58/ and they disclaim any appeals to institutions or courts that do not comply with the Code.

Any breach made by an organization or a person will result in licence withdrawal.

As for scrutineering taking place on Saturday and Sunday, the organiser reserves the right to accept only those competitors with whom the date of the scrutineering has been agreed in advance (with at least one day notice).

Track Driving: -The track can only be used during practice and the race. Any breach will result in withdrawing the driver from the race.

Results: -Results will be displayed on the official notice board at the end of each practice / race.

Parc Fermé: -will be situated next to the pit lane entrance.

Prize Awarding: -prizes will be awarded at the end of the last race in the relevant day. The first three winners are obliged to attend the awarding ceremony.

12. Track:
- length: 4.400 m
 - direction: anticlockwise
 - number of turns 7 + 4 „chicanes“

13. Briefing:
- the exact date of the briefing will be announced in regulations for carrying-out
 - Participation in briefing is obligatory !!

14. Starting Procedure:

- **Standing Start** - after a Warm-Up, the vehicles take their starting positions, if there is no warning signal the red lights and board signalling “5 sec.” appears. Start occurs right after switching off the red lights.

- **Rolling Start** - following the Safety car, all vehicles will gradually make formation during the formation lap, as they approach the starting grid by speed 70-90 km/h, the Safety car turns to the pit lane and leading drivers keep formation. Red light appears, followed by green light what means start.

15. Practice:
- Friday, Aug. 22nd 8am – 4pm free practice (charge : SKK 1.500,-)
 - official practice (monitored) available only for vehicles that have been scruteneered by a scrutineer, the timetable will be displayed on the official notice board
 - each race will include only one official practice

16. Speed limit in the pit lane:

Speed limit in the pit lane is 60 km/h and is to be radar monitored.

17. Parc Fermé: -vehicles must remain in the parc fermé once the practice / race has finished, till the parc is re-opened by stewards of the meeting. During this period no repairs / modifications on vehicle are allowed unless requested by a scrutineer.
18. Stop & Go: - STOP & GO is situated at the end of the pit lane, next to the entrance lights
-DRIVE THROUGH (through the pit lane)
19. Paddock a pits: -only authorized persons are allowed to enter the pit lane
- the pit lane will include a zone reserved for mechanics. This is to be visibly separated from the pit lane
-„pits are open. Drivers mechanics are responsible for any material brought in.

21. Timekeeping: -will be realized by the means of transponders AMBTranx260. These are to be distributed during administration a budú zálohované licenciou pretekára. V prípade poškodenia alebo straty zo strany súťažiacého /jazdca/ bude účtovaná čiastka 10.000,- Sk za transpondér.

22. Restrictions

Responsibilities

All participators take part in the event at their own risk. They hold the whole civil and criminal-law responsibility for any damage or injury caused by them or their vehicles.

Addendum to the Regulations

The organiser reserves the right to amend the Regulations.

23. Supplementary Rules:

- Identification name-plates of persons and entrance— each participator is due to wear their identification name-plates during the event.

The competitors are entitled to obtain an identification name-plate as follows: driver, mechanics (2x), mechanic's box (2x), driver's team (1x), vehicle entrance (2x).

- Insurance – each driver is due to be covered by accident insurance.

- **Paddock** – Only team members and participants' service cars are allowed to the paddock. Civil vehicles belonging to participants and members of teams are to be parked within reserved parking place in paddock. Paddock entrance will be opened from Aug. 16th 2008 (10am) till the beginning of the first official practice. Due to airport service, it is to be emptied by Aug. 20th 2008 (6am) at the latest. The speed limit in the area is 20km/h. All participants must follow the instructions of organiser's team that is responsible for maintaining order and, pursuant to the consent of the race director, it is entitled to keep out non-disciplined participants.

24. General Provisions:

All above-mentioned provisions are to be agreed upon in accordance with the valid prescriptions of the International and National Sporting Codes.

By participating in the event, all drivers and competitors confirm their acquaintance with the above-mentioned provisions and they agree to obey them as well as to follow instructions of the organising committee, race headquarters and appointed officials.
